Part II:Certification	 authority of Norway: where the relevant diseases are notifiable to the competent authority and reports of suspicion of infection of the relevant disease must be immediately investigated by the competent authority; all introduction of species susceptible to the relevant diseases come from an area declared free from disease, and; species susceptible to the relevant diseases are not vaccinated against relevant diseases; where there are a surveillance scheme to control these disease. 							
	 The milk and dairy products come from herds free from tuberculosis and brucellosis. The milk and dairy products originate from Norway that have been declared by OIE as free from food and mouth disease since 1952. The milk and dairy products come from herds that are not infected with food and mouth disease nor under the suspicion of being infected at the time of milk collection and are not vaccinated. The product was processed in a foot and mouth disease-free country, without vaccination. The milk or the milk from which the dairy product was made originated from a country recognized by the OIE as free from Lumpy skin disease.
